Vibration and Air Overpressure Summary July 2020

Seismic research during the past forty years has established criteria which relate the occurrence of structural damage to certain levels of ground motion. Vibration damage criteria are now commonly expressed in terms of particle velocity, the rate of ground movement at a given point produced by ground vibrations as they pass that point.

The Present laws for coal mine blasting in Alabama near occupied structures limit the peak particle velocity to 1.25 inches/second for distances of 0 - 300 feet, 1.0 inch/second for distances of 301 - 5,000 feet, and 0.75 inch/second for distances of 5,001 feet and greater. The airblast is limited to 133 dBL (for this particular instrument). These laws apply to all surface mines under new permits as issued by the Alabama Surface Mining Commission

Seismograph Results

For the period beginning July 01, 2020, and ending July 31, 2020, the maximum peak particle velocity was **0.73 inches/second with a corresponding frequency of 28.4 Hz**. This event was recorded at the CROSSFIELD PROPERTY LINE seismograph location. The blast associated with the maximum recorded vibration occurred on July 31, 2020 at 12:40.

The maximum air overpressure, which occurred on July 31, 2020 at 12:40, was **120 dBL**. The event with which this level is associated was recorded at the CROSSFIELD PROPERTY LINE seismograph location.
